In addition to this, if elected, I plan to continue to expand on the work of the previous VPSAs such as the podcast, VPSA Chats, and working with the Student Advisory Committee.

Prior to starting college, I served in the United States Navy from 2011-2017. I was honorably discharged as an E-5 and my title was AME2 (AW) Goodin. My rate, or job, was Aviation Structural Mechanic, Safety Equipment and I worked on the F/A-18 Legacy Hornet, variants A-D, and the E-2 Hawkeye, variants C and D. My duties included maintenance, both scheduled and unscheduled, on forty and then five aircraft, respectively. The systems I was trained to work on were ejection seats, oxygen (both gaseous and liquid) systems, environmental control systems, wing de-ice systems, and fire detection and suppression systems. During my time in the Navy, I held a variety of job titles to include Work Center Supervisor, Collateral Duty Inspector, Quality Assurance Safety Observer, Training Petty Officer, Tool Control Petty Officer, Enlisted Aviation Warfare Specialist on both the F/A-18 and the E-2 Hawkeye, Flight Deck Observer, and Final Checker. During day to day operations, I was responsible for representing my workcenter and presenting our workload at beginning and end of shift maintenance meetings, training junior sailors on the proper maintenance manuals to use during job actions, and logging all training in our work center systems. During my time as a supervisor there were many occasions where I had to represent the Navy in a professional capacity.
