My name is Brittany Woodruff, and it is with great pleasure that I announce my intent to run for the position of Vice President for Student Affairs for the 2021-2023 biennium.

I am a Spring 2013 initiate and Life Member of the Pi Chapter of Kappa Kappa Psi at Auburn University, where I majored in Interdisciplinary Studies with focuses in mechanical engineering and biology. I am 26 years old, and will be 27 by the start of the 2021 National Convention. I plan on attending the National Convention in Grand Rapids, barring any worsening of the COVID-19 pandemic. While I am running for Vice President for Student Affairs, I am open to the idea of serving in any position.

I marched clarinet in the Auburn University Marching Band, and played bass clarinet and contrabass clarinet in Auburn's Symphonic Winds and Concert Bands. I also was selected to participate in the 2013, 2015, and 2017 Alabama Intercollegiate Band and the 2019 National Intercollegiate Band on bass clarinet and contrabass clarinet. I have also performed with Dr. Brian Viliunas's clarinet studio on bass clarinet every semester since the spring of 2012 at his invitation. I continue to play bass clarinet in the East Alabama Community Band in Auburn, Alabama.

I want to be Vice President for Student Affairs because I believe I can make a difference in the lives of brothers. I know this is what everybody says when they're running for national office, but I truly believe I can make an impact. I want to have personal investment in the lives of our brothers, and really let them know that they have someone on the National Council that is rooting for them. I also want to assist chapters and districts in any manner they may need. I have seven years of experience as an active brother serving in many different ways. I believe that my experiences are useful for helping chapters who need new ideas, a nudge in the right direction, or someone to just listen to their struggles. I also have experience in convention planning, both in logistics and in creating content. While I know that this is largely taken over by the new National Coordinator position, I still believe that I can help councils and host chapters and provide support.

Since my initiation into the Pi Chapter in 2013, I have served Kappa Kappa Psi in a variety of roles on the chapter, district, and national levels.

While I have never had formal leadership roles in Pi as a member of the Executive Council, I have served my chapter in a variety of roles and held several appointed positions. As a member of the Nu Nu Colonization Committee from the start of my initiation, I helped the Colony Chair manage paperwork and streamline communication to and from the colony. I also attended the colony's First and Second Degrees of the Ritual. Nu Nu's First Degree as a colony occurred 6 days after I was initiated, and was my first real experience meeting brothers from other chapters and bonding over a shared love of Kappa Kappa Psi and the Ritual. This experience was instrumental in serving as Colony Liaison to the lota Nu colony in 2016, where I led the performance of all three Degrees of the Ritual in coordination with brothers from the Theta

Theta Chapter at the University of Alabama at Birmingham. I also was part of the group of brothers that performed all Degrees of the Ritual, the Colony Initiation Ceremony, and the Graduating Senior Ceremony at the Kappa Kappa Colony at Miles College in March of 2020, coordinated with Pi, Nu Nu, and former Kappa Kappa brothers. These experiences with colonies are useful for the office of VPSA because I have interacted directly with colonists, heard their complaints and seen their complications with the colonization process, and ensured positive performances of the Ritual. It is more specifically useful to VPSA because if colonists do not feel they have their voices heard by the National Council, why should they think they would as active brothers? My time with colonies has also been useful because it has provided me with the opportunities to coordinate with brothers across the state, which has improved my communication skills.

My first standalone leadership role in the Pi Chapter was serving as the service coordinator for the AU Symphonic Winds trip to Italy in 2016. Similar to how Pi plans gameday service, I created lists of crews for bus loading and unloading and coordinated which bus's luggage or instruments would be placed on for each city traveled to, and to airports. This experience directly led to my second standalone leadership role in the chapter, where I served as Summer Camp Chair. Every year, the Auburn Chapter of the National Band Association sponsors summer camps for middle school and high school band members. I communicated regularly with the camp director and graduate teaching assistants to gauge how many volunteers would be required at what times across two weeks of camps. I then created sign-up sheets to be sent out to the Pi Chapter and the Theta Lambda Chapter of Tau Beta Sigma. Any change in plans, from weather to availability, were communicated through me from the camp director or graduate teaching assistants to the volunteers.

Additionally, I have been a member of the host chapter of Southeast District Convention in 2016 at Auburn University and in 2020 at Callaway Gardens, Georgia. I assisted in organizing service requirements and shifts, space allocation, costs, and running a help desk. While the 2020 Southeast District Convention was moved online, I had already attended Winter Council and sent out sign-up sheets to the chapter. Along with the other members of the SEDC Committee, I helped create a website, t-shirt design, and had a plan for a quick turnaround between the performance of each organization's ritual. My experiences in service coordination and logistics are useful for the office of VPSA because I am able to assist host chapters, chapter service chairs, and District Councils in those areas. I also have experience in hosting District Convention at both a host school and a host site. Additionally, it demonstrates that I am organized and capable of coordinating small- and large-scale events and the manpower required for such events.

In 2018, I was appointed to be the Pi Chapter's first-ever Ritual Chair. I was tasked with forming a Ritual Committee to regularly inventory and evaluate Ritual materials, set up and break down Ritual sets, and coordinate speakers at Ritual and our Joint Ceremony with the Theta Lambda Chapter of Tau Beta Sigma. I also was in regular contact with Chris Haughee about how to create Ritual-based Continuing Membership Education presentations for the chapter. I presented one for each Degree along with members of the Ritual Committee, highlighting

important symbolism and events in each and encouraging discussion of what those meant or represented to individual brothers. I also pushed for the creation of a budget for the Ritual Committee, which was established after my graduation. Our Ritual is one of the most important parts of Kappa Kappa Psi and my experience in performing and sharing knowledge of the Ritual is important for any member of the National Council, but uniquely so for VPSA during the COVID-19 pandemic as current VPSA Bang Co helped organize performances of the Ritual for chapters who could no longer perform in person.

I also served as the chair of the Audit Committee in 2018 and 2019. I was responsible for organizing the committee and deciding on meeting times, and was given access to the chapter bank and Venmo accounts. This voluntary committee met once a year to conduct an audit of the chapter Treasurer, note any discrepancies, and make recommendations to the chapter. We reviewed the chapter Venmo account, bank statements, and ledger to make sure chapter funds were being used properly and as reported. This attention to detail makes me an asset to the fraternity and would be useful in any office.

I served as the Pi Chapter delegate for the 2018 and 2019 Southeast District Conventions. In 2018, I also was chosen to be the Student Keynote Speaker at the first separate session of convention. My speech was entitled "Kappa Kappa Psi Matters - How the Ritual Inspires Us to Strive for the Highest." Additionally that year, I served as the Jurisdiction Committee Chair. Much of my work was initiated before convention, organizing the changes to the District Constitution to be voted on in a way that would lessen the time it would take to vote on legislation. However, I spent much of my time at convention communicating with District Officers, Governors, and Counselors from both Kappa Kappa Psi and Tau Beta Sigma. I also worked directly with my counterpart in Tau Beta Sigma to pass joint legislation, clearly laying out expectations for District Leadership Conference and the way the district was going to host Southeast District Convention moving forward.

In Fall 2018, I was selected to be the Kappa Kappa Psi Chair for the Eighth Note Committee, the Southeast District's joint publication. The committee was made up of eight members, four per organization, and two student advisors. The positions were Chair, Graphic Design, Editor, and Public Relations, as well as the Kappa Kappa Psi Vice President of Programs and the Tau Beta Sigma Vice President of Special Projects, who served as the student advisors. One of our charges was to publish multiple editions of the publication within the school year, rather than the previous pattern of a single issue released at Southeast District Convention. The Eighth Note was also on its last legs as interest in participating on the committee and submissions had dwindled over the years. In fact, legislation had been drafted the previous year to remove the Eighth Note as an official program of the district, but the Joint-Actions Committee decided to give it one more chance. To increase interest, I led the committee in implementing an interview system, where committee members would sit down with alumni, actives, and membership candidates from across the district through Skype, email, phone calls, or in person. Members of the committee also interviewed people directly at the 2019 District Leadership Conference. This was to make participation with the Eighth Note seem less daunting, as people no longer had to write their own articles. By the end of the school year, the Eighth Note released four full

publications and one mini edition, totalling over 30 submissions. These experiences are useful for serving as VPSA because I learned how to actively communicate across organizations throughout an entire school year, keep people accountable for deadlines and deliverables, and connect with members of the district and showcase their achievements. These skills are directly relatable to working with the National Communications Team in showcasing the work that brothers do across the country.

At the 2019 Southeast District Convention, I was also appointed the Kappa Kappa Psi Chair of the Joint-Actions Committee, where we reviewed bids for the 2020 Southeast District Convention location, ways to improve joint relations, and created a rubric for how to evaluate bids. While again, most of this has been made the responsibility of the National Events Coordinator, I still believe that my experience is useful for helping the National Council evaluate and decide on future host locations. I also gained much from this experience again from working across organizations, through lunch breaks, and even after banquet. It also brought me into an amount of conflict with District Governors and Counselors, but through active listening and communication, we reached a compromise.

After graduating in December of 2019, I joined the Southeast District Alumni Association. I was also chosen to give the keynote speech at the 2020 District Leadership Conference, speaking on Strength, Excellence, and Diversity in the Bond. In April 2020, I was elected to the SEDAA Board of Directors, and from there selected to be the Finance Chair. Since then, I have implemented an annual audit policy, checking the Venmo history against the ledger. I also led the Finance Committee in hosting a virtual fundraiser in the fall of 2020 to raffle a Life Membership to graduating seniors and alumni. The Life Membership was purchased with permission at the discounted rate for Boh's birthday, maximizing the potential profit for SEDAA. Overall, SEDAA totaled a net profit of \$295. This experience is useful for VPSA because it shows I can help chapters conduct fundraisers online, even amidst a pandemic that has taken away most of the usual in-person options.

Professionally, I currently work as a service industry professional at Country's Barbecue in Auburn, Alabama. The service industry is widely stigmatized, but I believe it has offered me a unique perspective on how to interact with brothers. As a server, I have interacted with customers from a wide variety of backgrounds and temperaments. My coworkers are similarly diverse. The job has also taught me to think ahead for potential needs of customers and how to pay close attention to detail. Through my time at Country's, I've gained patience, learning how to talk to different groups, task prioritization, and time management. I have regularly met with SEDAA, the Finance Committee, and performed my duties as Finance Chair, so I do believe that I can successfully maintain a work-Kappa Kappa Psi-life balance if I were elected as VPSA.

While at Auburn, I studied Discipline-Based Education Research (DBER) and Student Development Theory. Student Development Theory comprises multiple sub theories, including Mindset Theory, Validation Theory, and Identity Development. The more I studied, the more I realized that sometimes, you just need someone to be there for you and support you. Studies have shown that personal investment by professors results in happier, more successful students

across all types of universities. So brothers, why shouldn't personal investment by someone on the National Council result in happier, more successful brothers?

Without getting too technical, Validation Theory was created to help low-income, first-generation college students, as well as non-traditional students, succeed in higher education. It has since been adapted to address the struggles that minorities, neurodivergent, and LGBTQIA+ students face in college. In the diverse membership of Kappa Kappa Psi, I believe these practices can be applied to our membership to help brothers thrive.

This doesn't mean that I plan on just lecturing brothers or only telling them how great they are; I want to focus on the things that our brothers are doing well. I want to advocate for you and help in places you are struggling. I want to help provide you with resources for success, even after your time as active brothers.

The pandemic has taken away many of the experiences that make Kappa Kappa Psi unique. Newer members have not been able to participate in the Ritual in person, we have not had the option to have fellowship at in-person district or national events, and our service opportunities have been vastly limited or altered. I want to help chapters figure out how to proceed moving forward. We don't know what the future holds in the midst of a global pandemic, but I want to give chapters the guidance and tools to succeed.

This may seem like a lot of abstract goals, but here are concrete plans I have on how to support brothers.

- Continue VPSA Chats on topics that brothers find interesting
- Work with the Student Advisory Committee to check in on brothers as individuals and as chapters
- Work with the National Communications Team to continue showcasing the incredible work that not only chapters do, but individual brothers as well
- Host workshops on how Student Development Theory can help brothers
 - These are not meant to be lectures, but ways to help brothers reframe their worldview and grow as people
- Create a series of short "How To Adult" videos featuring members of the National Council, District Alumni Associations, etc.
 - These are meant to be light-hearted informational videos, such as "how to sew a button" or "how to file taxes" to help brothers for future endeavors, as well as humanize and highlight these brothers who might seem unapproachable
- Help chapters create a game plan for filling in the gaps for the experiences that brothers have missed out on during the COVID-19 pandemic
- Create a Kappa Kappa Psi style guide, explaining when it is appropriate to capitalize terms as they apply to the fraternity (e.g. Degree, Brothers, Council)

Brothers, I love Kappa Kappa Psi and the people that make it truly wonderful. I would be honored to serve as your Vice President for Student Affairs, and represent you, the brothers. Band matters, Kappa Kappa Psi matters, but most of all, you matter.
