Brothers of the National Chapter:

It is with delight that I write to submit my materials for candidacy for the Kappa Kappa Psi Board of Trustees.

Few people know what being a Trustee means. Being a Trustee is not about acting on day to day matters of the Fraternity, but rather is about looking at the threats and long-term opportunities confronting us. Threats can include legal issues, risk not well managed, or decline in resources or membership. Opportunities can include ways to gain new resources outside of annual dues, considering new approaches to advancing the college band movement, or building new strategic partnerships and plans for Kappa Kappa Psi. Understanding this broader picture is critical to the Fraternity and is the special role of the Board of Trustees.

My work at the University of Michigan has grown in complexity especially in this year. As Managing Director for the Center for Research on Learning and Teaching, I had key responsibilities for preparing UM as we pivoted to online instruction, and then shifted to multiple ways of teaching (in person, hybrid, and online). My role includes serving on a small central team leading UM through its 2020 accreditation (among the first institutions to do this during COVID), leading university-wide teaching and learning grant administration, supervising a team of 14 consultants, and helping plan the array of programming needed for our instructors make the shift to the teaching needed during the pandemic. My work in university administration has also spanned into student life, including research and assessment for strategic planning, risk management and reduction, student conduct (including serving as a hearing officer for 20 years), and general problem solving. In many ways, my career was built for crisis moments.

What I have done in these areas has been enhanced by my roles in Kappa Kappa Psi, including my current Fraternity positions. Since the time that I finished my previous term on the Board of Trustees, I have served as a chair for the Capital Campaign, the largest fundraising effort in the history of our Fraternity. At this writing, the current Board is still designing its final plans for celebration at the 2021 National Convention. I have continued developing the opportunities that emerged from the Hazing and Values Task Force to talk with directors across the country about dilemmas large and small. Seeing campus as both a faculty member and from within a teaching and learning center gives me special appreciation for the needs of our directors as they are leading band programs and teaching academic classes during a pandemic. I had the privilege of helping the initial brainstorming of the 2020 district conventions, which directly overlapped with the challenges our campus was facing, giving me the ability to share common ideas and solutions to achieve our mission even during a public health crisis. Throughout all of this, I serve as Nu chapter sponsor, which gives me the ability to talk with students all the time who are navigating all that the world is throwing at them.

At the same time, our nation navigates a moment of racial reckoning that we see play out in numerous ways every day on campus. Racial equity is a conscious decision that must infuse every decision on campus and within our Fraternity. How we continue to expand Kappa Kappa Psi's inclusiveness require our constant attention. Though Trustees do not directly oversee programming and day-to-day decisions, evaluating opportunity, appeals, and risks for the Fraterity demands honest adherence to equitable examination. While we navigate a racial reckoning in specific, we also must examine equity in numerous ways without losing a focus on becoming more anti-racist. We must do this with clarity about how this is unfolding on campus, and I bring that clarity.

Kappa Psi has thrived through this pandemic. Even so, we have chapters who are struggling. As we emerge from the pandemic, college band programs will be even more relevant than ever before as community builders as we emerge from the pandemic, but they need special support to be funded and strengthened in the ways that the post-pandemic world will require. I look forward to engaging that effort in another term on the Board of Trustees.

This work to enhance individual accountability rose to the attention of HazingPrevention.Org, resulting in my joining their Board of Directors and bringing bands to the conversation.

- Throughout my previous Trustee work, we navigated complex strategic transitions for the Fraternity, including evaluating future opportunities for Kappa Kappa Psi to promote college bands. I have worked with other Brothers to lay the groundwork for both values-based education for students and capital development for the corporation. This taps into curricular and development projects that I have guided at UM.
- As Nu Chapter Sponsor, I serve at the local level of Kappa Kappa Psi. I work with Brothers to translate ideas into promotion of the Michigan bands and strong Brotherhood ties. These students provide the day-to-day reality check about the impact of what we are doing at the national level.
